- I will **obey all reasonable directions** from the Field Trip Leader.
- I will **not** attend if I am unwell and until acute symptoms have cleared.
- I agree that I must, at all times, **take reasonable care** of my own safety and take reasonable care that any acts or omissions do not adversely affect the health and safety of others.
- I will wear appropriate clothing for prevailing weather conditions (sturdy, enclosed footwear and hat are required).
- I will stay clear of hazardous areas or dangerous locations (e.g. cliff edges, mine shafts, quarry faces and open slopes).
- I will **behave** in an orderly and respectful manner at all times.
- I will respect the property of others at all times such as that of landowners and places where I am accommodated.
- I will not leave my group without notifying the Field Trip Leader of my intended movements in time and place.
- I will not take any prohibited items on the trip (see Field Trip Guidelines).
- I will not use recreational drugs, and if alcohol is permitted at the site or by the Field Trip Leader, I agree to limit the
- consumption of alcohol to ensure that I do not endanger my own safety or the safety of any other person.
- I understand all volunteers are expected to assist in housekeeping duties as directed by the Field Trip Leader.
- I will undertake any training arranged or recommended by the Field Trip Leader.
- I have disclosed details of any **medical or health-related condition** which could impact on my ability to undertake the assigned activities and I hereby **give consent** for medical treatment to be administered to me in the event of a medical emergency.
- I understand that, as a volunteer I am covered for **personal accident insurance** but **I will not be covered** by the University's workers' compensation insurance.
- I also understand that, under the provisions of the *Volunteers Protection Act 2001*, I will **not be held personally liable** for an act or omission conducted in good faith and without recklessness regarding any activity undertaken by me as a volunteer provided that:
 - o my ability to perform the tasks is not significantly impaired by my use of recreational drugs or alcohol;
 - I act within the scope of activities authorised by the University; and
 - o I do not act contrary to instructions given to me by the University.
- I understand that if the volunteer work to which I am assigned involves working with children, disabled, aged and/or vulnerable persons, I will be required to obtain the necessary **clearance** in the relevant state/territory before starting the volunteer work. (See Department of Human Services (SA), Working with children clearance (NT))
- I understand that I must **not disclose**, disseminate or otherwise make use of intellectual property or confidential information relating to the University' affairs, or personal information relating to individuals, that I may have access to during the course of my engagement as a volunteer in the University.
- I understand that the University reserves the **right to terminate** my engagement as a volunteer at its absolute discretion. More information on volunteers can be found at Volunteers and health and safety.
